Pay.Gov provides a suite of services and interface options through which Pay.Gov processes collections in an efficient, timely, secure manner for Federal agency programs. The Federal Reserve Bank of Cleveland in conjunction with the Department of Treasury helped design and develop Pay.Gov to support their enterprise-wide commitment to processing electronic collections from numerous federal agencies, the primary exception being the payment of federal income taxes. All communication between Pay.Gov and its customers are encrypted. Pay.Gov provides for authentication of all customers except for public form submission(s) and public bill payments which do not require authentication by design that is stored in fully encrypted database.

The Federal Reserve Bank of Cleveland has developed a public-facing mobile application that leverages services provided by Jack Henry and Pay.Gov for payment card transaction processing.
